

# Workshop 1: Forest Ecosystem Services in Oceania - progress in research, policy and decision making.



## Forest Ecosystem Services Forum

Christchurch, New Zealand. Monday 2 September 2019, 8:30am - 5:00pm

Organised by Scion, the Forest Ecosystem Services (FES) forum builds on the success of the annual FES forums held since 2012 in New Zealand, and in 2017 in Brisbane. The forum aims to facilitate a debate on the role of planted forests and to increase awareness of FES by bringing together key stakeholders who are interested in applying the natural capital and ecosystem services concepts.

The FES Forum will:

- Showcase the latest advancements from Oceania and around the world in recognising and accounting for ecosystem services in policy and decision making.
- Identify the gaps and challenges for moving forward, and how these lessons can influence current and future policies (e.g. afforestation, reforestation, and climate change adaptation and impact investments).
- Explore the development of research proposals that will address both short- and long-term needs of the government, businesses and key community groups concerned about the management of the natural capital stock and the FES that enhance human wellbeing.

Participants will gain a better understanding of the challenges of informing policies that include forest ecosystem services, including issues surrounding a social license to operate. We will build on our collective knowledge through small group discussions to explore how these challenges could be overcome.
